17 **COMPLAINT FOR DIVORCE**

9 adjudicated, and divided by this Court.
- 10 8. There is separate property, the full extent of which needs to be identified and  
11 confirmed by this Court to each as their sole and separate property prior to the  
12 community property distributions.
- 13 9. There is community debt, the full extent of which needs to be identified, adjudicated,  
14 and divided by this Court.
- 15 10. That child support should be set in congruence with Nevada law.
- 16 11. That both parties maintain medical insurance through their employer for the minor  
17 child. Any deductibles and expenses not covered by insurance should be paid by  
18 equally by both parties under the "30/30 Rule."
- 19 12. That XXXXX receive the tax exemption for the minor child every other year.
- 20 13. That neither party be entitled to spousal support in any amount.
- 21 14. The parties are incompatible in their tastes, natures, views, likes, and dislikes, which  
22 have become so widely separate and divergent that they are incompatible in marriage  
23 with no possibility of reconciliation.
